## EXHIBITION AGREEMENT AND REGISTRATION FORM

- 1. NAME OF EXHIBITION:** UCTEA Chamber of Mining Engineers, 5<sup>th</sup> International Drilling Congress and Exhibition of Turkey
- 2. CONTRACTORS:** Organizer of the Exhibition UCTEA Chamber of Mining Engineers (hereafter CHAMBER) and participant Companies (hereafter COMPANY).
- 3. LOCATION and DATE:** FUARİZMİR (Zafer District. 840 St. Gaziemir/İzmir), 27-28 October 2022
- 4. EXHIBITION ORDER**
  - 4.1 The outlines of the exhibition area will be provided by the CHAMBER. COMPANY will exhibit its products and services in the areas allocated to them in accordance with the terms of this contract. CHAMBER has the right to change the general layout of the exhibition area when it is necessary. Please find attached the outline of the exhibition area. The required information related to the product or service have to be provided by the COMPANY's booth attendant.
  - 4.2 The Company, which rents the neighboring booth, may be changed due to the arbitrary reason. For these reasons, the other COMPANY cannot regard the CHAMBER as responsible and cannot make claim on change.
  - 4.3 The COMPANY is responsible for the damage that may occur in the exhibition area caused by transportation. The COMPANY cannot show the CHAMBER as buyer for any product shipped or send to the exhibition area. The COMPANY cannot claim compensation from the CHAMBER for reasons such as incomplete and incorrect deliveries, damaged materials, wrong storage of the any material.
  - 4.4 **Standard Booth:** The system that is rented to the COMPANY during the congress consisting of the melamine coated chip-board panel and aluminum profiles which defines the boundaries of the booth having numbers of facades which is predetermined in the project. There are two chairs for each of the booth, one desk, one trash can and one socket included to the booth system. Extra services and equipment requests by COMPANY before the date October 10, 2022 will be provided for the fee if it is approved by the CHAMBER. Since the standard booths have no carrying property, it is not allowed to drill or nail the panels and stick the advertising material on it. Only light weighted pictures are allowed to put it on and the use of the double-sided tape is demanded. The products to be exhibited should be designed to remain in the airspace belonging to the booth area.
  - 4.5 **Special Booth:** The Special Booths belongs to The COMPANY must be designed so as to remain within its own area and airfield. The sizes of the booths will be determined by CHAMBER and cannot be carried to the neighboring booths and corridors, cannot be pierced and anchored. Only the double-sided tapes can be used for the carpets and similar materials to be affixed to the floor, and it is necessary to clean these tapes from the booth while dismantling of the booth. Adhesive materials are strictly forbidden. CHAMBER leaves a socket the COMPANY at any place of the booth area for the use of electricity. The COMPANY is responsible for the distribution of the electricity and lighting. The COMPANY is responsible for any kind of damage and hazard given to the facilities of the Exhibition Area by itself.
  - 4.6 CHAMBER may change or remove the booth of the COMPANY if it is determined that a violation of rights has occurred against other companies by COMPANY as a result of the placement/removal of other companies in violation of their rights or in the evaluation of the complaints received by the CHAMBER.

## 5. EXHIBITION TERMS

- 5.1 Exhibition opens in October 27, 2022 at 11:00 and closes in October 28, 2022 at 18:00.
- 5.2 The COMPANY have to finish all the preparation works before the October 27, 2022 at 08:00. The COMPANY have to keep the booth open during the exhibition period and have to remove the all materials regarding to the booth before 20:00 on Friday, October 28, 2022 at least.

- 5.3 COMPANY have to obey the opening (at 09:00) and closing (at 18:00) hours defined by CHAMBER. Overnighting is not allowed at the area of booth.
- 5.4 Any inside and outside movement of the exhibited materials is forbidden during the exhibition hours.
- 5.5 Any haulage, loading and unloading have to be carried out with by taking the safety issues into consideration as prescribed in the law numbered 6331.
- 5.6 During the loading/unloading and transportation works in the exhibition areas, it should be done with maximum safety and no confusion should be caused.
- 5.7 The security and the insurance of the exhibited materials are all in the responsibility of COMPANY. Given the size of the exhibition are and the crowd, CHAMBER does not provide guarantees about security and does not bear any responsibility. Any kind of fire, nature and community events that may occur during the exhibition dismantlement, theft etc. CHAMBER is not responsible for damages and loss of lives that may arise due to these reasons, and COMPANY is obliged to take necessary precautions. COMPANY is responsible for ensuring the safety of its booth, display products and equipment and putting precious items in locked rooms.
- 5.8 All the materials regarding to booth, have to be rendered to the CHAMBER with its original form. COMPANY is responsible for any harm or damage given to the booth material.
- 5.9 COMPANY should not drill, pound nail and staple anything to the floor or the walls. Adhesives and fasteners that will not harm the physical structure and the environment should be used in fixing and fastening processes. COMPANY is liable for any damage or harm on exhibition area.
- 5.10 In case the instruments such as Video, tape, CD player etc. to be used in the booths disturb other participants, the CHAMBER has the right to cut off the source of the noise after a verbal warning.
- 5.11 Exhibition of any inflammable materials i.e., petrol, gas etc. is forbidden. Any material with possible harm to the human health or illegal materials are forbidden. COMPANY is responsible for the violation of these terms.
- 5.12 COMPANY staff have responsibility of knowing the location of the emergency exits.
- 5.13 COMPANY should not locate any material out of the area of the booth allocated to them. Advertising materials are only allowed for sponsored companies. No materials can be hung down from the dashboard in the exhibition area, nothing can be fixed to the floor.
- 5.14 FUARİZMİR Management is responsible for the cleaning of the corridors located outside of the booth area. COMPANY is responsible for the cleaning of the booth area.

## 6. BOOTH RENTS

- 6.1 Exhibition Area Unit Fee: 120 €/m<sup>2</sup> + VAT.
- 6.2 The participants who filled the payment form and exhibition registration form (COMPANY, institution or organization) accepts the exhibition agreements and has to fulfill the obligations.
- 6.3 CHAMBER has the right to accept or reject the COMPANY seeking to participate in the exhibition. Payments made by COMPANY who are rejected, will be fully refunded.
- 6.4 Reservations for the exhibition area will be valid until October 06, 2022. After the date, reservation will be deleted and CHAMBER have right to rent the reserved booths to the other COMPANIES.
- 6.5 In case of cancellation of participation in the exhibition, 20% of the exhibition fee will be deducted and the remaining amount will be refunded. For this, the cancellation application must be made in literal to the Congress Secretariat until October 13, 2022.
- 6.6 Terms of agreements will be valid after the payment of the exhibition participation fee and shipment of the Exhibition Registration and Payment form to the congress secretary. The company, which does not pay until October 13, 2022, will not be allowed to set up stands and participate in the exhibition.
